Meeting called to order by Chairman Barnes at 7:00 p.m. in the Pella Public Safety Complex, 614 Main Street, Pella, Iowa.

It was moved by Hansen, seconded by Blomgren to approve the April 2, 2019 minutes. Motion carried 6-0.

Chairman Barnes opened the call to the public. Comments were received from two members of the public: Danny Nugteren and John Bandstra.

It was moved by Blomgren, seconded by Pinney to approve Resolution No. 32 entitled, "APPROVING AMENDMENT #2 FOR TASK ORDER #1 WITH HDR ENGINEERING, INC."

Motion carried 6-0.

As background, Task Order #1 was originally approved for the purpose of conducting a public information meeting to satisfy Iowa Code Chapter 6B requirements for governmental projects planning to acquire agricultural property. Amendment #2 under consideration is for the purpose of general planning and engineering services conducted by HDR Engineering including time spent working with the Mahaska County Board of Supervisors as well as general work not associated with other task orders. The estimated not-to-exceed fees for Amendment #2 total \$19,930. If approved, below is the updated summary of the fees for Task Order #1:

BACKGROUND: Jerry Searle, HRD Engineering Inc. was recently contacted

by Mazitello Professional Services regarding the proposed 350 foot Mahaska County 911 tower under consideration by the County. A location that has been under consideration for the project is the Mahaska County Secondary Roads facility located at 2074 Old Highway 163

or Highway 432 in Oskaloosa.

As discussed during the most recent SCRAA Executive Committee meeting, the Committee recommends the SCRAA Board approve a motion directing Jerry Searle to draft and submit a letter to Mahaska County objecting to the Secondary Road location, as well as any other location that may adversely impact approach minimums for the

South Central Regional Airport project.
