Exhibit A

Task Order 07: Request for Federal Release Pella Municipal Airport Pella Airport

Scope of Work

This task order pertains to an Agreement by and between South Central Regional Airport Agency (SCRAA), Owner, and HDR Engineering, Inc. ("Engineer"), dated November 17, 2017, ("the Agreement"), Engineer shall perform the services on the project described below as provided herein and in the Agreement. This task Order shall not be binding until it has been properly signed by both parties. Upon execution, this Task order shall supplement the Agreement as it pertains to the project described below.

TASK ORDER NUMBER: 07

PROJECT NAME: South Central Regional Airport Development

PART 1.0 PROJECT DESCRIPTION:

The City of Pella owns and operates the Pella Municipal Airport. The City will retain the services of Ahlers Cooney P.C. to review the abstract and other title history for the property to be shown on the Exhibit "A" Airport Property Map. All land as shown on the Exhibit "A" Airport property map is considered federal obligated regardless by the manner by which it was acquired. The City of Pella recognizes that it must address contractual obligations related to federal assurances as set forth between the City and FAA. Prior to disposal of federally obligated real estate, the city is required to prepare and submit to FAA for approval "Request for Release". FAA Order 5190.6B, "Airport Compliance Manual", Chapter 22 "Releases for Federal Obligations" outlines the documentation and procedural steps required. The release documentation will be based on an FAA approved Exhibit "A" Airport Property Map. The Exhibit "A" Airport Property Map on file with FAA was prepared in 1995.

PART 2.0 SCOPE OF SERVICES TO BE PERFORMEND BY ENGINEER ON THE PROJECT:

1. EXHIBIT "A" AIRPORT PROPERTY MAP

The Engineer will prepare an Exhibit "A" Airport Property Map based on information provided by Ahlers Cooney PC (Attorney). The attorney will:

- Review the current Exhibit A on file with FAA.
- Review the abstract and other title history related to the Pella Municipal Airport
- Prepare a legal opinion regarding the current and future status of the property to be shown on the Exhibit A.

The Engineer will develop the Exhibit "A" Airport Property Map in accordance with guidance provide in FAA SOP 3.0. The Exhibit "A" Airport Property map must be accepted by FAA before a partial or full release can be considered.

The attorney will contract with the City of Pella. The City will verify that the Title opinion prepared by the Attorney is in accordance with guidance provided in FAA Order 5190.6B.

2. Survey

The Engineer will contract with Garden and Associates (Surveyor) to provide an outer boundary survey and legal description of airport property as shown on the Exhibit "A" Airport Property map. If there is airport real estate as shown on the Exhibit A that is not needed to support current airport operations, the City may consider requesting a partial release from federal obligations. At present, a determination regarding land for which there is no "aeronautical purpose" has not been made. If there is one or more parcels of property for which there is not aeronautical purpose and the City decides to dispose of such parcels, the Surveyor will be tasked with preparing a plat of survey and legal description for each of those areas.

3. Archaeological/Historic Surveys

The FONSI issued (6-9-2017) by FAA requires an archaeological survey be undertaken in the SE corner of the airport and coordination with the Iowa State Historic Preservation Office (SHPO) be completed prior to any of the airport real estate or assets that are federally obligated could be released. This work would be initiated in the spring of 2020. The Engineer will contract with Wapsi Valley to complete this task.

The disposal of airport assets and the ultimate closure of the Pella Municipal Airport was included in the Environmental Assessment (EA) prepared for the South Central Regional Airport-Replacement Airport.

4. Appraisal (s)

Where the disposal of real estate is expect to exceed one million dollars, FAA requires two (2) appraisals and a review appraisal. The appraisal reports are good for six (6) months after which FAA may require they be updated. Since a determination has not been made regarding how many parcels or when such parcels may be released and disposed of, an amendment to this (Task Order 07) will be required prior to the work being initiated. The number of amendments will vary subject to the number of parcels and when the City decides to dispose of one or more parcels. The Engineer will retain the services of Commercial Appraisers of Iowa to prepare the Appraisal and Brian Linnemeyer to provide the review Appraisal. If an additional appraisal is needed, the Engineer may use the services of Iowa Appraisal and Research.

The appraisal reports will be prepared in accordance with the Uniform Standards of Professional Appraisal Practice (USPAP) and FAA guidance.

5. Release from Federal Obligations

The Engineer will summarize why the release of non-aeronautical land in each phase is being requested and provide a time line for the partial disposal and ultimate closure of the airport. The Engineer will provide an inventory of assists acquired with state and or federal assistance. The Request for Release will describe the Fair Market Value (FMV) (based on fair market value appraisal) of assets to be disposed of or transferred to the South Central Regional Airport Agency (SCRAA). The Engineer will describe the project benefit related to the disposal or transfer of assets. It is understood the revenue generated will be reinvested in accordance with FAA requirements in the proposed South Central Regional Airport. The Engineer will submit the report and supporting documentation to the City of Pella and FAA for review and comment. The FAA Central Region (upon receiving an acceptable document) will coordinate with the FAA Associate Administrator for Airports and if approved, publish the determination in the federal register. Obligated airport property being disposed of must be appraised at the highest and best use.

The Engineer will provide for the coordination of efforts undertaken by the attorney, land surveyor and appraisers. In addition the Engineer will coordinate and assist in negotiation with FAA as may be required.

6. Budget

The scope of work includes tasks 1 through 5, shown on the Attachment 1. Since the effort required to complete cannot be fully determined, it is expected Task Order 07 may be amended from time to time to account for additional as may be required.
